You are being invited to participate as a talker in the recording of speech materials for use in research. Before you decide whether or not to take part, it is important for you to understand why the research is being done and what it will involve. Take time to decide. You should only participate if you want to; choosing not to take part will not disadvantage you in any way.

Please read the following information carefully and discuss it with others if you wish. If you have questions or require more information before deciding to take part, please contact one of the researchers using the contact details listed below.

What is the purpose of the study?

In group scenarios, where several people are talking at once, it can be hard to hear what someone is saying. The project aims to develop improved signal processing techniques for smart devices worn on the head, such as augmented reality glasses, "hearables" and next-generation hearing aids. We refer to these devices using the generic term "head-worn microphone arrays." The algorithms being developed by us, and other researchers around the world, may make use of spatial information about the position/orientation of the people present. To evaluate the effectiveness of these algorithms we are making high quality multimedia recordings of group scenarios made under controlled conditions.

Why have I been invited?

You have been invited to participate because you are a healthy adult of the age, gender, language and regional dialect required for our recordings. You will participate in groups of 6 and there will be up to five groups altogether.

Do I have to take part?

It is up to you to decide whether or not to take part. If you choose not to participate, you won't incur any detriment. If you do decide to take part you will be given this information sheet to keep and be asked to sign a consent form.

What will happen to me if I take part?

You will attend one or more recording sessions. You will wear a headset containing a microphone to record your voice and a sensor for tracking your head position and orientation.

One person in the group, designated "the listener", will also wear a prototype "head-worn microphone array." This consists of a pair of safety glasses which has several microphones attached and a binaural headset which positions two microphones at the entrance to your ears. You have the option to consent and volunteer to be "the listener" but since only one person in each group can perform this role not everyone will be able to.

The 6 people participating in the recording will be seated around a table in two rows of three and asked to take part in the following activities, designed to make you talk in a natural manner:

- 1. Read text you will each read aloud a few paragraphs of text, lasting approximately 30-60 seconds each.
- 2. Group conversation you will take part in a short game as a whole group. This will last 5-10 minutes.
- 3. One-to-one conversations you will talk to the person opposite you about a specific topic using prompts provided. This will last 5-10 minutes.

During the recordings, loudspeakers will be playing ambient noise at a level consistent with a typical café or restaurant.

To protect the privacy of the other participants and yourself, it is important that you do not refer to anyone using their real name or say anything which could be used to identify any of the participants.

You may consent and volunteer to participate in just one session or in multiple sessions. Each session will follow the same procedure and last up to an hour. Each session will be in a different room on the South Kensington Campus. All sessions will take place during June 2023.

What are the possible disadvantages and risks of taking part?

We do not anticipate any risks, discomfort or distress from taking part in this project. If you do experience any discomfort or distress, please inform the researchers.

What if something goes wrong?

If you are harmed by taking part in this research project, there are no special compensation arrangements. If you are harmed due to someone's negligence, then you may have grounds for a legal action. Regardless of this, if you wish to complain, or have any concerns about any aspect of the way you have been treated during the course of this study then you should immediately inform the Investigator (Alastair Moore – alastair.h.moore@imperial.ac.uk). If you are still not satisfied with the response, you may contact the Imperial College Research Governance Integrity Team (rgitcoordinator@imperial.ac.uk).

What will happen to the results of the research study?

The recordings and a report detailing the method of data collection will be uploaded to a public data repository and linked to from the Speech and Audio Processing page of the Imperial College website (https://www.imperial.ac.uk/speech-audio-processing/resources/) so that other researchers can use them to evaluate their

signal processing algorithms. None of your personal information will be included in this or any subsequent report which uses the recordings. However, the recordings will contain your voice, from which it may be possible for someone to identify you.

Public access to the recordings will be maintained for 15 years. Please note, once the recordings have been published, they will be in the public domain. Therefore, once the recordings have been downloaded and used by other organisations they will be beyond the College's control. If you are not comfortable with this then you should not participate.

Who is organising and funding the research?

The research is being conducted by members of the Department of Electrical and Electronic Engineering at Imperial College London. The research is funded by Meta Platform Technologies, LLC (formerly Facebook Technologies LLC).

Who has reviewed the study?

In consultation with the Imperial College Research Governance and Integrity Team (RGIT), it was determined that this study is considered a "Service Evaluation" and therefore no specific ethics review is required.

SUMMARY INFORMATION SHEET

In this research study we (Imperial College London) will use information from you. We will only use information that we need for the research study. We will let very few people know your name or contact details, and only if they really need it for this study. These people will include Imperial Research Team members and support staff.

Everyone involved in this study will keep the data collated as part of this study, including your personal data, safe and secure. We will also follow all privacy laws and legislation that are relevant to the specifics of the study.

People who do not need to know who you are will not be able to see your name or contact details. Your data will have a unique study number instead.

We will keep all information about you safe and secure.

Once we have finished the study, we will keep some of the data so we can check the results. We will write our reports in a way that it is unlikely anyone can work out that you took part in the study.

LEGAL BASIS

We will conduct scientific research in compliance with the law and the recommendations and quidance published by the UK Information Commissioners Office (ICO). This will follow similar rules to health and social care research but may not meet the definition of the College's public interest task or requirement. In such cases we will be holding and using your data for what are called our "legitimate interests" where, as previously stated, the College aims to conduct world leading research and innovation aiming to deliver transformative impact for society. Scientific research should serve the public interest, which means that we have to demonstrate that our research has societal impact serving the interests of society as a whole.
